

SOFT CRATES

The Kennel Club has asked that we draw attention to the potential health and safety implications concerning the use of soft crates as in its view, they do not offer sufficient protection to dogs. They have asked that we point out that dogs should **not** be left unattended in soft crates. There have been instances where dogs have escaped from soft crates which have not been securely fastened to benches, or that have been left at ringside.

We therefore ask that if you use soft crates that you do not leave dogs unattended either in the hall or even in an open car in the car park.

IDENTIFICATION OF DOGS

It is now a Kennel Club requirement that exhibitors display the exhibit/bench number on their crate, cage or container at all times. This is particularly important when cages, etc. are not on benches and at unbenched shows.

Each exhibitor is responsible for providing their crate or cage identification and should note that the original exhibit/bench number card, as provided by the show society, must not be used for this purpose.

This requirement follows a meeting of the Show Executive Sub-Committee's Benching Work Party, where it was agreed that it is important to be able to contact exhibitors and identify dogs where a dog may be in distress or where the crate might be blocking a passageway.

At benched shows soft crates may only be put on benches if they are the appropriate size for both the dog and the bench, and the crate can be securely attached to the bench.

Both of these points have been introduced with the safety of all in mind, but most importantly that of the dog, and to minimise the potential incidents and injuries.

REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F(B)

1. These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A 42.
 - (a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained there at.
 - (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A42.
2.
 - a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the Show. No substance which alters the natural colour of any external part of the dog may be present at any time during the Show.
 - b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:-
 - (a) Operations certified to the satisfaction of the General Committee.
 - (b) The removal of dew claws of any breed.
 - (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown.Nor must anything be done calculated in the opinion of the General Committee to deceive.
4. The General Committee without previous notice may order an examination of any dog or dogs at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may however, be lodged by an official of the Show or by anyone so deputed by the K.C. It will be the responsibility of the individual who lodges the objection or the official (as appropriate), to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.

Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint

I/We declare that where any alteration has been made to the dog(s) natural conformation the relevant permission to show has been granted by the Kennel Club. I/We further declare that, to the best of my/our knowledge, that the dog(s) are not liable to disqualification under Kennel Club Show Regulations.
