In case of dispute proof of postage of such applications may be required by The Kennel Club. Puppies under 6 months of age on the first day of the Show cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after it's name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. The Kennel Club Authority to Compete number (for dogs registered and resident outside the UK) must be stated or the entry will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.

DECLARATION

I/We also undertake to abide by the Regulations of this Show and not to bring to the Show any dog which has contracted or been knowingly exposed to any infectious or contagious disease during the 21 days prior to the Show, or which is suffering from a visible condition which adversely affects its health or welfare or to bring any dog which has been prepared for exhibition contrary to Kennel Club Regulations for the Preparation of Dogs for Exhibition F (Annex B). I/We agree without reservation that any Veterinary Surgeon operating on any of my/our dogs in such a way that the operation alters the natural conformation of the dog or part thereof may report such operations to the Kennel Club. I/We declare that where any alteration has been made to the dog(s) natural conformation the relevant permission to show has been granted by the Kennel Club. I/We further declare that, to the best of my/our knowledge, that the dog(s) are not liable to disqualification under Kennel Club Show Regulations.

DOGS IN VEHICLES ON DAYS

Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. If your dog is found to be at risk, forcible entry to your vehicle may be necessary without liability for any damage caused.

SOFT CRATES

The Kennel Club has asked that we draw attention to the potential health and safety implications concerning the use of soft crates as in its view, they do not offer sufficient protection to dogs. They have asked that we point out that dogs should not be left unattended in soft crates. There have been instances where dogs have escaped from soft crates which have not been securely fastened to benches, or that have been left at ringside. We therefore ask that if you use soft crates that you do not leave dogs unattended either in the hall or even in an open car in the car park.

IDENTIFICATION OF DOGS

It is now a Kennel Club requirement that exhibitors display the exhibit/bench number on their crate, cage or container at all times. This is particularly important when cages, etc. are not on benches and at unbenched shows. Each exhibitor is responsible for providing their crate or cage identification and should note that the original exhibit/bench number card, as provided by the show society, must not be used for this purpose. This requirement follows a meeting of the Show Executive Sub-Committee's Benching Work Party, where it was agreed that it is important to be able to contact exhibitors and identify dogs where a dog may be in distress or where the crate might be blocking a passageway.

At benched shows soft crates may only be put on benches if they are the appropriate size for both the dog and the bench, and the crate can be securely attached to the bench. Both of these points have been introduced with the safety of all in mind, but most importantly that of the dog, and to minimise the potential incidents and injuries.
